- Mr. PSRK Prasad (Treasurer) has briefed the fund position to the GBM as under –
 - Fixed Deposit in KVB – Rs. 10,00,000/-
 - An interest of around Rs. 50,000/- per annum with the present interest rates would be added to the Savings Bank account.
 - Fixed Deposit by NARVA – Rs. 1,00,000/-
 - The interest against this deposit is being spent by NARVA School for merit students. Due for the last three years.
 - Balance in Savings A/c – Rs. 3,76,386/-
